## **SEWER CONTRACT**

This contract is between the Town of Harmony, NC, organized and operating under and by the laws of the State of North Carolina, hereafter called the Town, and \_\_\_\_\_, a resident, business or owner of property in Harmony or of the area being served sewer by the Town, hereafter called the customer.

WHEREAS, the customer desires to purchase sewer service from the Town and to enter into a contract as required by the policies of the Town.

THEREFORE, in consideration of the mutual covenants, promises and agreements herein contained, it is hereby understood and agreed:

The Town shall furnish, subject to the limitations hereafter provided, sewer service to the Customer at the property described above.

The Customer shall install and maintain at his own expense a cut off valve, a back water valve when necessary and a service line which shall start at the sewer tap and shall extend to the Customer's building.

In signing this contract the Customer agrees to pay for sewer service based on the water usage that registers on the Iredell Water Corporation water meter and shall pay the rates set by Town policy. The Customer also agrees to pay such deposits and penalties as set out by Town policy.

The Town shall have final authority in any question of location of any service line connection to its collection system. The Town may shut off sewer service to a Customer who allows a connection or extension to be made to his service line for the purpose of supplying sewer service to another user.

The failure of a Customer to pay sewer charges duly imposed by the Town shall result in the automatic imposition of the following penalties:

- A. Payment not received by the 20<sup>th</sup> of the month by the Town for sewer service will be subject to a penalty of 10% of the delinquent account.
- B. Payment not received by the Town within 30 days of the due date will result in sewer service being shut off from the Customer's property.

In the event it becomes necessary for the Town to shut off the sewer service from a Customer's property, a fee will be charged for reconnection of the service in accordance with Town policy.

The customer agrees to allow Town personnel to enter Customer's property for the purpose of shutting off and/or reconnecting the sewer service for this purpose.

Customers shall not alter, bypass or unlawfully reconnect cut off valve and shall be prosecuted by the Town as authorized by NC Statute 13-151.1.
